



PARENT/GUARDIAN INFORMATION FORM REGARDING FINANCIAL ASSISTANCE

We know that YOU understand the importance performing arts play in developing stronger life skills and **we wanted to allow you an opportunity to sign your child for the exciting journey of strengthening theirs..**

Our Snow Pond Summer Arts Camp will run **Monday through Friday, for grades 1-8**. There will be one full day of camp the week at a cost of \$195 and 5 weeks of half-day afternoon camps that are \$125 per week. Each day that your child is on the Snow Pond campus they will have the opportunity to participate in swimming, hiking, and/or other outside recreational activities, weather permitting. A nutritional snack(s) will be provided for each child that does not have serious allergies, and the curriculum has been developed to unleash the imagination and creativity in each child no matter what level skill set they are at. The program will vary from week to week depending on the theme but may include:

- Drawing, painting, printmaking, or sculpture for the art portion.
- Percussion, ukulele, vocale, theory and composing for music.
- Cultivating acting and behind the scene skills, improving improv expertise, and many other exciting specialty projects for theater.

One more additional benefit of the Arts camp is the chance to be surrounded by music and culture of the New England Music Campers and Staff who will be there during the half day camps. Maine does camp well and New England Camp does Music Camp extraordinarily well, the atmosphere and music that the Snow Pond Arts Campers will be hearing float through the air of the campus is an exceptional experience they won't soon forget.

There will also be opportunities for you AND your family to sit in on free concerts performed by the staff and campers of NEMC, as well as special discounts on our summer music series. **Our goal is to provide more children an opportunity to be exposed to more of the arts which we know makes MAINE a better place to be!**

Of course we understand that sometimes families need help and so we have provided this informational sheet to take advantage of the programs and tax credits they are eligible for. We ask you to start at Step 1, and proceed through the steps of the financial process. We also would like your help as we are looking into the reimbursement through the Child and Adult Care Food Program (CACFP) and would appreciate your help to fill our the Income Eligibility Forms.

1. **CHILD TAX CREDIT through the Federal Government while filing your IRS taxes**

The Child Tax Credit is an important tax credit for working families. If you believe that you are eligible for this program please contact your CPA or tax accountant for more information. We will provide you with the proper paperwork you will need upon request.

Here is some information regarding the state tax credits:

Dependent Care Tax Credit

The Maine dependent care state tax credit is equal to 25% of the federal credit for child and dependent care expenses. The credit doubles if the expenses are related to a quality child care provider. This credit is also refundable up to \$500.

The Maine legislature passed a law that expands the income tax credit for child care expenses. A Maine taxpayer who enrolls a child in a child care center or home with a Quality Certificate is eligible for a double child care tax credit on their state income tax return. An individual is allowed a credit against the tax otherwise due in the amount of 25% of the federal tax credit allowable for child and dependent care. In the new law, this credit doubles in amount if the child care expenses were incurred through the use of programs with Quality Certificates. The credit may result in a refund of up to \$500.

To qualify for the double tax credit, the number from the child care provider's Quality Certificate will need to be entered on a Maine State Income Tax Return. This is **not** the number on a child care license, but the 3 digit number on a Quality Certificate.

Quality Certificates

The Maine legislature passed a law that expands the income tax credit for child care expenses. A Maine taxpayer who enrolls a child in a child care center or home with a Quality Certificate is eligible for a double child care tax credit on their state income tax return. Currently an individual is allowed a credit against the tax otherwise due in the amount of 25% of the federal tax credit allowable for child and dependent care. In the new law, this credit doubles in amount if the child care expenses were incurred through the use of quality child care. The credit may result in a refund of up to \$500.

Snow Pond Summer Arts Camp Program is currently working towards a Quality Certificate to make our program eligible for the double tax credit on the state income tax return.

Earned Income Tax Credit

While the Earned Income Tax Credit is not directly related to child care, it is a way that low-income parents can receive money to pay for child care or other expenses.

This is a refundable Federal tax credit for eligible families who work and have earned income under \$32,121 (for a taxpayer with more than one child and meets all other qualifying requirements). The EITC reduces the amount of tax owed and it may result in a refund.

2. Maine's Child Care Subsidy Program

The Child Care Subsidy Program helps eligible families to pay for childcare so they can work, go to school or participate in a job training program. Eligible families must meet the [income guidelines](#):

And at least one of the following activities: work, school, or job training program. You can apply for Child Care Subsidy in one of the following ways:

- At local DHHS office (Office of Family Independence-OFI)
- Online at www.maine.gov/MyMaineConnection
- Once you are determined to be **financially eligible**, you can proceed to step 2 which is:
- Complete the Child Care Subsidy Program Application (you can get this from OFI or OCFS) and return it to the Office of Child and Family Services (OCFS):

- Once you are determined to be **program eligible**, and the provider you choose is approved, payments will be made directly to your provider on your behalf.

You will have a co-payment that you will need to pay to your provider (Snow Pond Summer Arts Camp Program) and the Child Care Subsidy Program will pay the rest to your provider. The co-pay is also based on income. You can find more information and find how to apply at the link below.

MAINE INCOME ELIGIBILITY REQUIREMENTS ON THE NEXT PAGE

CLIENT INCOME ELIGIBILITY CRITERIA

Individuals eligible for child care subsidy from the Department of Health and Human Services must comply with income eligibility criteria below.

Funds	State Funds (SPSS) Fund for a Healthy Maine (FHM) Child Care Development Funds (CCDF), Temporary Assistance to Needy Families (TANF) Social Services Block Grant (SSBG)
Income Eligibility	All families must meet income guidelines of gross family income at or below 85% of the State Median Income.
Fee Assessment	Fees are assessed to all families.

MAXIMUM INCOME GUIDELINES – CHILD CARE SERVICES

For families with more than one child in care, the youngest child is always considered the first child enrolled. The total amount of assessed fees to a family shall not exceed 10% of the family’s gross income for all of their children.

Weekly fee assessments must be rounded down to the nearest dollar. All assessed parent fees shall be paid directly to the caregiver by the parent.

Financial Aid & Scholarship Application

Snow Pond Summer Arts Camp Program financial aid is based on the financial situation of the child's family, and any extenuating circumstances (extraordinary events, and continuing hardships) with consistent guidelines that apply to all applicants.

Please consider the value of this experience for your child when deciding the dollar amount you are committed to investing or helping to raise towards tuition. Most of our students seek several sources of funding to supplement the aid we are able to offer i.e. local clubs, relatives, fundraisers, etc.

A family investment and participation at some level is very important to our founding principle that "any deserving child shall be able to attend Snow Pond Summer Arts Camp Program". Please consider this seriously and ask for only what you need, as we want to help everyone that needs assistance.

The following are required for all financial aid and scholarship applications.

1. **Complete Financial Aid & Scholarship Application**
2. **Financial Documents:** (REQUIRED) Include a copy of pages 1 & 2 of most recent 1040 form(s). Black out your SSN If tax return covers a period more that 18 months prior, please include copies of most recent wage statements/stubs and explanation of any changes.
3. **Qualifications Statement:** (REQUIRED) Attach a statement explaining the reasons why the applicant is qualified and should be considered for financial assistance. Please see the website listing of named scholarship and the type of information that may qualify you for different scholarships.
4. **Special Circumstances:** Please attach a statement of any special circumstances that merit consideration (loss of job, catastrophic medical expenses, etc.)
